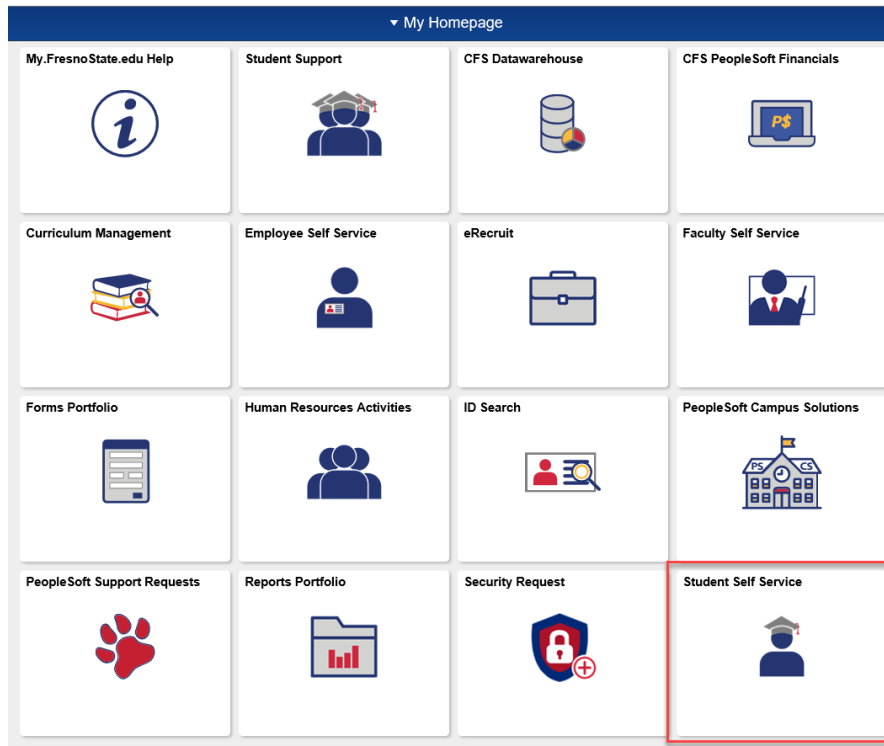
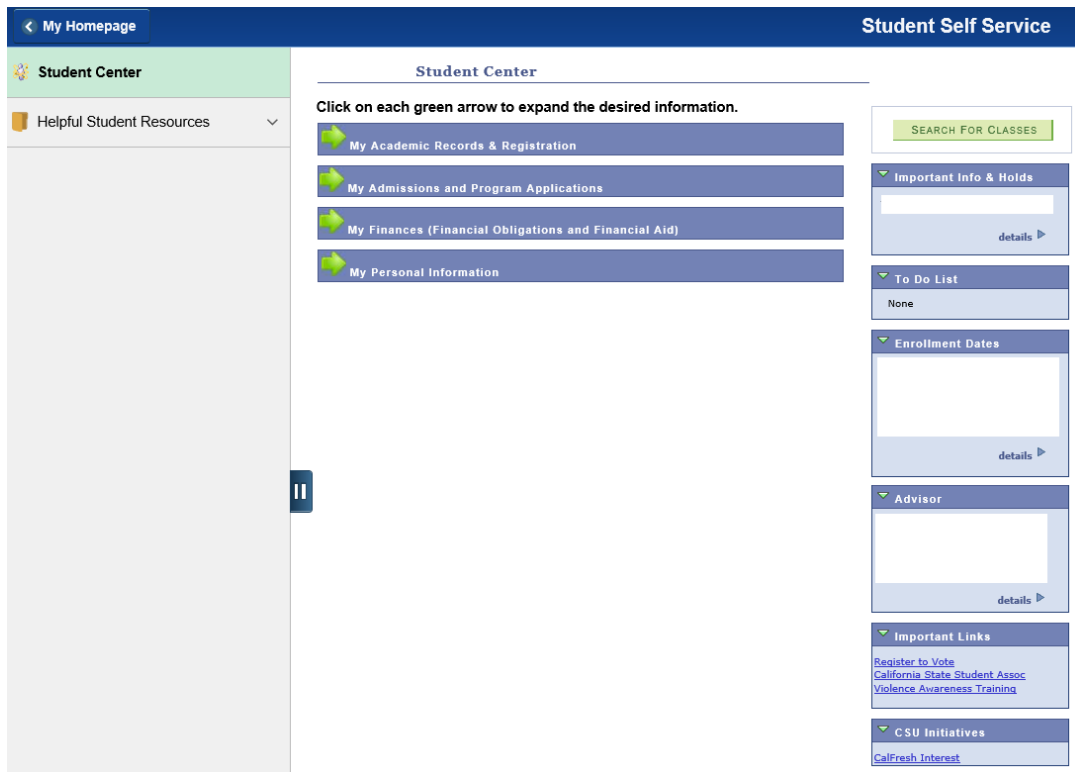


**Please Note: Continuing and Global/Extended Education students are not eligible for the payment plan.**
