

Fee Waiver & Reduction for Spring 2025

For Faculty, Staff, and Managers

Priority Processing Deadline: Wednesday, November 27, 2024

The Fee Waiver Program is a benefit available to eligible Faculty, Staff, and Managers within the CSU system. This program allows employees or one eligible dependent to enroll in CSU state-funded courses at a reduced rate at any of the 23 CSU campuses. The Fee Waiver & Reduction application can be found on the Human Resources website. Additional details regarding eligible fees, residency requirements, and taxation are also available on the CSU Fresno Human Resources website.

Please note: Courses offered through Continuing and Global Education, Open University, or Extended Education do not qualify for the Fee Waiver Program. Hourly employees (intermittent, emergency hires) are not eligible for this benefit.

Important Dates

Wednesday, November 27, 2024	Priority Processing Deadline for Fee Waiver Applications For Employees and Dependents Attending Fresno State: Submit the Fee Waiver & Reduction Application for Spring 2025 by 5:00 p.m. on Wednesday, November 27, 2024, to ensure the waiver/reduction is applied before the payment deadline.
	For Employees and Dependents Attending Another CSU Campus: Verify any deadlines with the campus you or your dependent will be attending. The Fee Waiver & Reduction Application must be submitted to the Fresno State Human Resources office at least one week before the deadline set by the attending CSU campus. Human Resources will review and forward your application to the applicable CSU campus.
November 28, 2024 – February 13, 2025	Applications received after November 27, 2024, but no later than February 13, 2025 (Census day/deadline for add/drop), may take up to 30-40 days to be processed. Students are responsible for ensuring timely payment of any tuition and fees not covered by the waiver. If the waiver is applied after November 27, 2024, students must pay any remaining balance on time. Add/drop deadlines can be found on the Admissions and Records website .
Friday, December 06, 2024	Payment Due Date and Student Account Balance Employees or dependents enrolled in courses for Spring 2025 must regularly check their student account and ensure that any balance due by Friday, December 06, 2024, is paid to avoid having classes dropped due to non-payment. Students are responsible for paying any tuition and fees not waived. If there is an overpayment after the Fee Waiver is applied, it will appear as a credit and be automatically refunded or applied to existing charges by Student Accounting.
