

# Fee Waiver & Reduction for Spring 2027

## Fee Waiver Submission Deadline: Monday, December 21, 2026

The Fee Waiver Program is a benefit available to eligible Faculty, Staff, and Managers within the CSU system. This program allows employees or one eligible dependent to enroll in CSU state-funded courses at a reduced rate at any of the 23 CSU campuses. Please note: Courses offered through Continuing and Global Education, Open University, or Extended Education do not qualify for the Fee Waiver Program. Hourly employees (intermittent, emergency hires) are not eligible for this benefit.

### Important Dates

December 21, 2026	<p><b>Priority Processing Deadline for Fee Waiver Applications</b> For Employees and Dependents Attending Fresno State: Submit the Fee Waiver &amp; Reduction Application for Spring 2027 by Monday, December 21, 2026, to ensure the waiver/reduction is applied before the payment deadline.</p> <p><b>For Employees and Dependents Attending Another CSU Campus:</b> Verify any deadlines with the campus you or your dependent will be attending. The Fee Waiver &amp; Reduction Application must be submitted to the Fresno State Human Resources office at least one week before the deadline set by the attending CSU campus.</p>
December 22, 2026 – January 12, 2027	Fee Waivers received on/after December 22, 2026, but no later than January 12, 2027, may take up to 30-40 days to be processed. Students are responsible for ensuring the timely payment of any tuition and fees not covered by the waiver. If the waiver is applied after December 22, 2026, students must pay any remaining balance on time.
January 13, 2027	<p><b>Payment Due Date and Student Account Balance</b> Employees or dependents enrolled in courses for Spring 2027 must regularly check their student account and ensure that any balance due by Wednesday, January 13, 2027, is paid to avoid having classes dropped due to non-payment.</p> <p>Students are responsible for paying any tuition and fees not waived. If there is an overpayment after the Fee Waiver is applied, it will appear as a credit and be automatically refunded or applied to existing charges by Student Accounting. <b>February 16, 2027 Census Date</b>	<b>Fee Waivers received on or after February 16, 2027 will not be initially accepted. Waivers received on or after Census Date are subject to committee review for approval or denial.</b>
